The tenure of the committee members is up to 04.08.2025. Further, the term of the special invitee shall be one year. The quorum for meetings, including the chairperson but excluding the special invitee, shall be three.

Any student who is dissatisfied with the decision of the Students' Grievance Redressal Committee (SGRC) may prefer an appeal to the Ombudsmen within a period of 15 days from the date of receipt of such decision.
